

Plan, Manage and Review Legislative and Safety Compliance for Work in Confined Spaces **City & Guilds Level 4 Award 6160-06**

Who Should Attend:

This unit is for managers that are responsible for organising planning and managing work in confined spaces. The manager may or may not supervise the actual job. It involves managing the work of others in, or at confined spaces; reviewing legal requirements; ensuring safety compliance; preparing procedures and appropriate documentation; and making suitable arrangements for dealing with emergencies.

Pre-Requisites or APL:

It is recommended to hold one of the following or have a working knowledge of the management of health and safety to a similar standard:

- NEBOSH National General Certificate in Occupational Health and Safety
- NEBOSH International General Certificate in Occupational Health and Safety
- City & Guilds Level 6 Occupational Health and Safety
- NCRQ Level 6 Certificate in Applied Health and Safety
- NVQ Level 5 or Level 6 in Occupational Health and Safety Practice

Requirements:

Have confined space working knowledge

Aim:

The aim of this unit is to reflect the national occupational standard for planning, managing and reviewing legislative and safety compliance for work in confined spaces. This unit covers both the water and non-water industry areas.

Outcomes:

On successful completion of the course, the student will have demonstrated their competence, knowledge and skills enabling them to meet the City & Guilds requirements to:

- Plan the management of work in confined spaces
- Manage confined space teams
- Record and review legislation relating to confined spaces
- Develop, monitor and confirm procedures for working in confined spaces
- Understand environmental, legislative and health and safety compliance
- Understand organisational requirements for confined space working
- Understand plant, tools and equipment for working in confined spaces
- Understand emergency arrangements and rescue plans

Compliance:

- Confined Space Regulations 1997
- National Occupational Standards for Working in Confined Spaces – EUSCS06

Duration:

5 days with 32 hours contact time initially, then mentored project work expected to take a further 45 hours.

Ratios:

Trainers 1:8 Students

Delivery Method:

Lectures, classroom work and project work post course. There is no practical training requirement.

Equipment:

This is purely a classroom based course and as such no training equipment is required.

It is required to have a laptop computer and means of note taking.

Assessment:

Course content is assessed by a combination of an externally set written exam and project work which must be completed within 10 weeks course attendance.

Certification:

This course can be certified by City & Guilds or by Outreach Rescue upon meeting the assessment criteria. For City & Guilds certification, there is an additional fee of £45, and printed certificates are provided. There is no additional fee for digital Outreach Certification, and results are recorded on the Outreach Rescue Database.

Certification is valid for 3 years.

Progression:

Recertification is recommended every 3 years. This course is not a prerequisite for any higher awards in Confined Space working.
